1 Purpose, Scope and Use

Archival and library materials are quite similar by nature in that they document human history, but due to different traditions, standards and practice of description archival materials are often not listed in library catalogues. Both communities are interested in representing archival and library materials in common catalogues. Librarians are interested to have detailed descriptions of archival materials, and archives – to use efficient search and retrieval capabilities of library catalogues. These Guidelines are intended (1) to represent archival materials in electronic catalogues for integrating access for both library and archival collections and using common retrieval instruments, and (2) to provide correct description of archival materials held by libraries in the format which is familiar and convenient for librarians.

For the purpose of this document, *archive* is "the whole of the documents, regardless of form or medium, organically created and/or accumulated and used by a particular person, family, or corporate body in the course of the creator's activities and functions. Archival description represents an archive (also known as "fonds"), which is a complex set of materials that share common provenance" (see ISAD(G)).

Archival description reflects highly hierarchical structure in which archival material is intellectually organized; it proceeds from general description of the collection to more specific descriptions of parts of the collection, and further (if necessary) – to single item level. These Guidelines focus on description of archival materials of collection level (i.e. collection or fonds – subfonds – series – subseries – file), but can be also applicable for the item level descriptions.

In general archives may include any types of materials. At most cases it would be language materials; but also it may be sound records, photos, etc. In the later case descriptions should reflect not only archival nature of the materials being described, but also material-specific features. Guidelines do not cover such material specific characteristics – they would follow rules established for specific types of documents, i.e. text, photographs, sound recordings, etc.

Section 2 gives the principles of using UNIMARC in presenting archival materials. Section 3 lists data elements that could be commonly included in the bibliographic description of archives and indicates where each data element would be placed in a UNIMARC record. Section 4 gives examples of full records for archives.

2 UNIMARC Form and Content Data

The most widely used standard for encoding machine-readable archival metadata is *Encoded Archival Description* (EAD), which is based on the provisions of the *General International Standard Archival Description (ISAD (G))*. Essentially, to present archival descriptions in UNIMARC we need to find appropriate location for EAD and/or ISAD(G) data elements in UNIMARC record. The table in Section 3 is the result of such matching.

Unlike bibliographic description, archival description can not be understood separately; archival material should be placed into the context, i.e. we need to indicate its place in the hierarchy; give the information about acquisition and processing; provenance, including administrative history or biographical note; organization and arrangement of the collection. Archival description in UNIMARC should also include major information on the context of archival material.

Archival control

Archival collection may include various kind of materials; character position 6 (type of record). It's a method of managing and describing materials taking into account first of all the contextual relationships between the items and their provenance that makes material archival. Character position 9 in the record label should contain "a" (archival control). Together with the code in label/6 it allows to indicate both aspects – type of material and archival nature of the materials.

Multilevel description

Archival description is normally presented in a highly hierarchical structure proceeding from general description of the collection to more specific descriptions of its components, description of each part being linked to its higher unit of description. To describe the hierarchy EAD uses a system of nested descriptions of components. In UNIMARC the whole hierarchy may be built using mechanism of linking entries (46- fields). Archival description in UNIMARC can be constructed with any desired level of detail – it may be collection level record, if it is sufficient, or it may be set of records for all the desired levels, these records being linked with 46- fields. At most cases it would be the fonds – series – file. If necessary, even item level descriptions may be included.

Each level contains only information relevant to that specific level. So such elements as medium designator, material specific fields used for photographs, maps, copy specific attributes, etc. would be used mainly at the item level. At the collection-level they would be used only if they refer to all the materials in the unit of description. In the later case they do not need to be repeated at the lower level of description.

Hierarchical level is indicated in the record label, character position 8 (Hierarchical level code). Additionally position of each level within the hierarchy is identified explicitly – description of each part of the collection is linked to appropriate higher level; also, each level of description is identified explicitly (field 251 – Organization and Arrangement of Materials). Standard archival units are used – fonds, series, file, item.

Organization and arrangement of the collection

One of major archival principles states that archival materials be arranged and described with careful attention to their original function and order. Field 251 – Organization and Arrangement of Materials may be used for the information about organization and arrangement of the collection.

Dates

Date(s) are one of essential elements of archival description (ISAD(G)). At least one of the following types of dates for the unit of description should be given: inclusive dates, i.e. range of dates beginning from the earliest to the latest one; bulk dates - the time during which the bulk of the contents of the materials in the collection were created; single date (not very often used for collection; only if the collection was created within a single year). If any date is not known exactly, estimated date is given, and this is indicated in the description (e.g. before 1943). Most rules for archival description recognize date(s) of the collection as part of its title, so dates may be entered into the field 200 - Title and Statement of Responsibility, subfields independent are not considered as part of title – field independent of independent publication, distribution, etc. may be used.

3 Data Elements and UNIMARC Location

Dictionary of data elements used in archival description follows General International Standard Archival Description (ISAD (G)). If necessary, any appropriate material-specific fields may be used (e.g. for photographs, sound records, maps, etc.).

4 Full Record Examples

The following examples show how the UNIMARC format can be used when presenting the hierarchy of archival descriptions.

4.1 Example 1

Appendix A: Table of Correspondence of EAD and UNIMARC

Table includes the most significant EAD elements/attributes which might be mapped to UNIMARC fields to convert EAD record describing finding aid to UNIMARC record briefly describing archival unit named in that finding aid, to present archival data in library catalogues.

Typically, UNIMARC record collection level is generated. Lower levels data may be included, though it will require additional analysis of EAD elements. UNIMARC record at collection level is generated from EAD data in the high-level <did> or other <did>-level elements. If mapping UNIMARC element depends on where EAD element appears (i.e. parent element) and / or on specific attribute values, it is specified in "EAD Tag Appearance / Attribute" column in the table. E.g. notation <controlaccess> / <corpname ROLE="subject"> means that element <corpname> is nested within <controlaccess>, and ROLE attribute in <corpname> is encoded as "subject".

A field or element in another descriptive encoding system (e.g. UNIMARC) to which an EAD element or attribute is comparable, may be specified explicitly in EAD record. Field (and/or subfield) may be encoded in ENCODINGANALOG attribute. The descriptive encoding system to which certain EAD elements can be mapped using the ENCODINGANALOG attribute may be specified in RELATEDENCODING attribute (e.g. RELATEDENCODING="UNIMARC"). If the RELATEDENCODING attribute is not used, then the system designation should be included in ENCODINGANALOG (e.g. ENCODINGANALOG="UNIMARC") when UNIMARC field(subfield) is specified in ENCODINGANALOG attribute the element is encoded according to that attribute. When the element can be mapped to several UNIMARC fields, additional analysis (e.g. analysis of ENCODINGANALOG attribute) is required to determine which UNIMARC field to generate.

The column listing UNIMARC tags specifies the use of subfields, where it is possible to find direct mapping at subfield level. In other cases additional semantic analysis and / or post-process editing may be required to map EAD elements to specific UNIMARC subfields. Also there is no attempt here to map indicator values for every element.
