#### Conference programmes

In Buenos Aires in 2004, our Section organized a programme jointly with Division VIII. The theme, *Changing roles of NGOs in the creation, validation and dissemination of information in developing countries*, was the perfect topic for both groups. Having a joint session meant that the programme was four hours in length. In order to keep the attention of our audience, we incorporated a “break-out” session inviting participants to share their own experiences with NGOs. This was successful. We had a higher attendance rate at the off-site session due to our being able to include social science academics and researchers. This was crucial to the success of the session since the theme concentrated on “meeting user needs”.

### **Discussion Group**

The Knowledge Management Discussion Group organized a well attended and lively session at Berlin in 2003. As a result, it was able to convince IFLA to create a new Section for Knowledge Management which met for the first time in Buenos Aires in 2004.

### **Publications and Translations**

The Section produces an annual newsletter in August.

The Social Science Section continued updating and adding to the “Survey of National Education Libraries”, an e-publication edited by Jakob Andersen.

The Section’s leaflet was translated into Spanish (already available in French, Russian and English) and was made available in electronic and print version.

The Section’s Treasurer translated the papers presented in 2003 and 2004 so they were available on the web in both English and French.

### **Project**

A project examining the feasibility of repeating the INFROSS study, initiated in 2002 and paid for by IFLA, was completed and discussed by the Section in 2003. It was agreed that Hans-Christoph Hobohm would investigate funding from UNESCO for the replication of the INFROSS study. Unfortunately, the funding could not be found so the idea has been temporarily abandoned. Professional priorities a, d, f, g, h, i would have been achieved, if we had been able to take forward the study.

### **Objectives for 2005**

The Section will produce a newsletter in January, in addition to the usual August issue.

In Oslo, the Social Science Section will present a session on “Evidence-based librarianship” with case studies from the social sciences. This will be presented by a leader in the field, Anne Brice.<sup>1</sup>

The section is currently negotiating with a publisher to produce a book containing a collection of papers on the topic of “NGO collaboration with the library/information community”.
