1. Welcome

Gulcin welcomed everyone to the meeting, and congratulated the Travel Grant winners (Danitza Noemi Coronel Tola and Roana Flores) who joined the meeting onsite.

5. Professional Committee

Patrick Donowski explained there were many unresolved issues and problematic processes in IFLA's governance currently. Legal claims are underway. He expressed hope that the Governing Board would take the lead but did not have too much information. Notwithstanding these issues, the program for WLIC 2022 looks good, including ARL's program.

New structures are still to be organized and there are at least two open sessions for interested people:

- Open access
- E-book lending

The Professional Committee is interested in more ideas, new tools and networking to create connections between different sections.

Q&A:

- Reggie: The OA processes are focused on global north. There is a gulf between global north and global south.
- Ellen Tise: Shed some light on Thursday's meeting where IFLA's President will have more
 information for the membership. She mentioned IFLA's OA statement (created in Malaysia).
 How to take this forward in this world. How can IFLA lead? IFLA needs to develop
 structures/strategies.

7. ARL Action Plan 2021- 2023

7.1. Strategic Direction 1: Strengthen the Global Voice of Libraries

7.1.1 WLIC 2023 Satellite Conference (Lead: Jim)

2023 satellite meetings are limited to Belgium, Luxemborg and the Netherlands. IFLA will share the finally approved list of possible host institutions in October. The group expressed concern about the delay in announcing the locations and the competition by all sections for locations. It is difficult to plan amidst such uncertainty. There is strong consensus about collaborating with other IFLA sections (esp. with host institution). Astrid made a request for a location. She is still waiting on a response. Gulcin asked if we should have a fully hybrid conference satellite?

Discussion ensued about possible topics e.g.

- Jim: Focus on developing global crises e.g. Arizona State University will work with libraries
 in Ukraine. How can Ukrainian libraries be of service (Oksana ?? from Ukraine was a
 speaker at LIBER recently).
- Julia Gelfand (observer): Focus on student success and the global reach of universities who compete to recruit students.
- Ursula: Explore collaborating with Sci/Tech Libraries section on data science.
- Xin: Academic success centered in global citizenship. Knowledge sharing and action.
- Karen: theme of collaborations between ARL and partners to further globalization (student success, emergencies) etc. Call for papers to focus on collaborations.
- Jerome noted there'll be competition for locations if we wait too long.

Reggie cautioned that success and crises are defined based on environment. Inclusion is key! An inclusive mindset should drive the agenda.

No clear theme emerged. Following all these ideas Gulcin and Jim will begin to meet with potential partners in other sections this week to explore ideas for collaboration. Reggie recommended that discussions be linked to Sustainable Development Goals (SDGs).

Jim: What will decision-making look like?

Lorraine: Pull together topics with open movement framework (open science, inclusion, student success)

Reggie: Have discussions against backdrop of SDGs.



Ellen Tise (observer): ARL seems to be closing in on reaching consensus. She agreed that SDGs should be linked to the topics and that we should think beyond IFLA (e.g. NGOs). The UN has done a lot of work in this area. NGOs in The Netherlands should be explored too.

Name it in the title: Open Agenda

Gulcin/Jim will explore topics with other sections.

Jim asked about the experience of satellite conferences at WLIC 2022.

Xuemo (observer) shared his experience of this week's satellite conference. Hybrid is here to stay. Vendor sponsorship was successful, but more speakers participated online. Not ideal given the various time zones. It needs to be better managed (e.g. pre-recorded like 2021).

Discussion ensured about what "hybrid" means for satellite conference in 2023.?

7.1.2 Blogs (Lead: (Vicki/Sharon)

The monthly blog offers diverse news and views from academic and research librarians around the world.

7.1.3 Hot Topics (Lead: Lorraine)

7.2 Strategic Direction 2: Inspire and Enhance Professional Practice

7.2.1 IFLA Journal Special Issue (Lead: Reggie) (see Appendix below)

Steve Witt (IFLA Journal Editor)) provided an outline of the process to launch a special issue. Reggie and Steve met recently and discussed the process (see Reggie's attached report). According to Steve it usually takes up to a year to create the processes (e.g. guest editors, abstract for theme, call for papers, review and revisions until papers are accepted, followed by copy editing by Sage). Two options are:

- a) Submit abstracts for review. If approved, then invite authors to submit a full paper.
- b) Peer review editors can take an active role in managing the process and do revisions until paper is accepted.



Gulcin thanked Steve and the ARL team (Reggie, Bertil and Jayshree) for their work on this project.

7.3 Strategic Direction 3: Connect and Empower the Field

7.3.1 Webinars (Lead: Reggie/Xin)

Next webinar: End of October. Reggie is the lead and will circulate the abstract on SDGs.

7.3.2 Travel Grant (Lead: Astrid)

First call was issued in February 2022. Received 31 applications.

Three successful applicants were from Zimbabwe, Philippines, and Bolivia.

Roana Flores (Philippines) and Danitza Noemi Coronel (Bolivia) attended the WLIC in Dublin.

Unfortunately Jerry Mathema (Zimbabwe) did not receive a travel visa to travel to Dublin.

Appendix: brief report on IFLA Journal Special issue

On Monday 11th July I met with Steve Witt as I was in Illinois. It was a fairly brief meeting to confirm our intention to publish the special issue.

I assured him of complying with academic rigour associated with the journal. Firstly, I shared with him that the editors of the issue will not be contributing manuscripts. We also agreed on double-blind peer review. It is my opinion that there is enough capacity within the committee to do the peer review. However, should there be a need to go outside the committee, we will consult with him. The one important condition was that the reviewers be familiar with the conditions within that specific geographic area. I am also making the assumption that the reviewers will be familiar with the content.

I shared with him the possible areas to draw the articles from – this list was generated by Jayshree. He cautioned that much has been published on the issue of COVID. My response was that we need to look at COVID and a paradigm shift. I would also like to propose that we look at how libraries are planning for the future using the pandemic as a springboard to conceptualise and reinvent services going forward. Steve shared that the IFLA Journal has published much content with regard to digital preservation. I would like to suggest that we park this issue for now. I mentioned the proposed webinar on SDGs – this excited him a lot. My suggestion is that when we prepare for this webinar, we inform the presenters in advance. I would have liked to have Bertil talk about his library and its contribution to achieving the SDGs. I have heard much about his University and its mapping of their teaching and learning and research agenda against the SDGs. If Bertil is happy to contribute a manuscript to the special issue, then I would like to suggest that we replace Bertil as a member of the editorial team and have him contribute to the webinar and submit the paper for publication in the journal.

Steve also indicated that the issue should contain between 10-12 articles. My suggestion is that we have few articles but more substantial. My suggestion is between 7-10. The word count should be between 5000 to 7000 words excluding references and abstract. This can be discussed at the business meeting and confirmed.

Steve offered to come and speak to the colleagues at the business meeting. Marisa and Gulcin you can decide on the invitation.

My proposed timeline, having not discussed this with the editorial team, is below. I am hoping that the rest of the editorial team will contribute to panel-beating the final timelines.
