	Discuss with section members and identify standards and guidelines that are best suited for all.	Section members	Starting after the 1 st year of the project

	Investigate potential virtual networking and collaborative technology (Funding may be needed for instances when there is cost for investigating technology)	Ad hoc committee	6 - 8 months
	Analyze results of the survey and investigation, summarize, and provide summary to section members.	Ad hoc committee	1 to 1 ½ years
	Test virtual networking and collaborative technology with targeted, alternated regions to determine their feasibility (Funding may be needed for technology that is not free)	Ad hoc committee, with specific section members	Start in 6-8 months through 1 ½ years.

How will you communicate your activities and results?

Regular updates and discussions via IFLA listserv and the section blog. At least one meeting every two months via Zoom and collaboration via Basecamp for ad hoc committee.

How will you measure the impact of your activities?

Pre-survey: A survey will be conducted to identify current technology and identify what strategies are working and what are not working.

Post-survey: After the strategies are implemented, another survey will be conducted to determine their effectiveness.
