

Culture and Development: Model National Workshop

This document sets out some basic ideas about how you can organise events based around the zero draft of a Culture Goal produced by the Culture2030Goal campaign. The goal is both to promote discussion between the culture and other policy sectors as a basis for defining what each should do to realise the potential of culture to drive development, and to gather feedback on the zero draft.

You could hold such a workshop online or offline, as a standalone event or as part of a conference, and should treat the suggestions below as suggestions. To note, we have given ideas for what you can do in a one-hour, two-hour, half-day or whole-day session. For a brief introduction to the Culture2030Goal campaign, see this [video](#). In terms of **invitees**, in addition to representatives of your own sector, you could look to invite:

- Representatives, ideally, of at least one other parts of the Culture2030Goal campaign (see the list of [core members here](#)),
- Representative of your National UNESCO Commission (see the [directory](#))
- Representative of a your National SDG Council if this exists (you could also identify the focal point for SDG work in your country from the United Nations' [Voluntary National Reviews page](#))
- Representative of other policy areas (ideally both governmental and non-governmental)

If you have 1 hour...

- Words of welcome (yourself and a UNESCO National Commission) (5min)
- Setting the scene (short summary of the [zero-draft report](#), including the goal) (10min)
- Panel discussion about what making culture a part of work on other policy goals could look like, and how the zero-draft could fit in with this (30min)
- Responses from government representatives (if not already on the panel) (10min)
- Close, and defining next steps (5min)

If you have 2 hours...

- Welcome (yourself and a UNESCO National Commission) (10min)
- Setting the scene (short summary of the [zero-draft report](#), not including the goal) (15min)

- Case studies of culture contributing to other policy goals (20min)
- Panel discussion about how to make culture a part – systematically – of work on other policy goals, including questions from the floor (45min)
- Responses from government representatives (if not already on the panel) (15min)
- Short presentation of the [zero draft](#) (10min)
- Close, and defining next steps (5min)

If you have 4 hours...

- Welcome (yourself and a UNESCO National Commission) (10min)
- Keynote, from someone who can tell a good story about culture contributing to wider goals, or who can provide a unique insight into the relationship between the two, potentially including Q&A (20min)
- Setting the scene (distilled version of the [zero-draft report](#), not including the goal) (15min)
- Workshop: what is the current level of awareness of how well culture is already integrated into broader policymaking nationally? Are there processes in place to allow for this? (30min)
- Reporting back from workshops (10min)
- Practical contributions of culture contributing to other policy goals – case studies (20min)
- Questions and brainstorming about other documented examples (10min)
- Break (15min)
- Panel discussion about what could be done to make culture a part – systematically – of work on other policy goals (30min)
- Workshop: what practical steps could be taken to place culture more centrally in wider development planning? (30min)
- Short presentation of the [zero draft](#) (15min)
- Moderated discussion with the floor (including, for example, polls) to engage with the draft, and the difference it could make (25min)
- Summary and close (10min)

If you have a day (i.e. 7.5 hours excluding lunch)

- Welcome (yourself and a UNESCO National Commission and another governmental representative) (15min)
- Getting-to-know-you exercise (5min)
- Keynote, from someone who can tell a good story about culture contributing to wider goals, potentially including Q&A (20min)
- Keynote from someone who can provide a unique insight into the relationship between culture and other policy goals, potentially including Q&A (20min)
- Setting the scene (distilled version of the [zero-draft report](#), not including the goal) (20min)

- Workshop: what is the current level of awareness of how well culture is already integrated into broader policy-making nationally? Are there processes in place to allow for this? Produce a shared map (40min)
- Reporting back from workshops (10min)
- Break (20min)
- Practical contributions of culture contributing to other policy goals – case studies (20min)
- Invite participants from the floor to share their documented examples (30min)
- Panel discussion, reflecting on examples shared so far, looking to identify commonalities in where culture is included, and what appear to be the facilitating factors (30min)
- Wrapping up from the morning (10min)
- LUNCH
- Opening of the afternoon – recap of what has been discussed so far (5min)
- Waking up exercise (5min)
- Keynote speaker who can talk about the SDGs as a whole – potentially from the Culture 2030 Goal campaign? (15min)
- Short presentation of the [zero draft](#) (15min)
- Moderated discussion with the floor (including, for example, polls) around the different elements of the draft, in order to look at what stands out and what is missing? (25min)
- Workshop: what changes would the draft, in its current state, imply to the way that government and non-governmental stakeholders act (30min)?
- Break (20min)
- Reporting back from workshops, including further suggestions on what could change in the draft (10min)
- Workshop: what practical steps can we take in our country to make culture systematically a part of work on other policy goals – define the first three steps that we want to take (35min)
- Reporting back from workshops, including seeking comments on each workshop's conclusions (25min)
- Summary, thanks and close (15min)
