1. Welcome and Apologies

Loida Garcia-Febo, MLAS Chair welcomed and thanked all the current Standing Committee Members, New Standing Committee Members, NPSIG Convener, and WILSIG Convener for their attendance today. Loy Jyoon, MLAS secretary informed that Hella, Chutima, Namutenya, Ruijuan, Halo Locher, Ana Carolina, Julia Demasi, Yanhang Wang, Imad Bachir, and Adama Kone send their apologies. The Welcome Meeting today is for the current MLAS members to meet with the new colleagues elected to MLAS for orientation as per onboarding and transition guidelines from IFLA HQ.

2. Introduction of MLAS Officers

MLAS has three Officer positions comprising the Chair, Secretary, and Information Coordinator. Loida Garcia-Febo from the United States is currently the MLAS Chair and Loy Jyoon Chin from Malaysia is the MLAS Secretary. There is currently a vacancy for the Information Coordinator position in MLAS as there is no volunteer for the position after Loida who was formerly the Information Coordinator was elected as the MLAS Chair in May 2023. Loida is now also carrying out the responsibility of the Information Coordinator until the term ends on 24 August 2023.

3. Introduction of Current and New Members

The Chair invited the current and new MLAS Standing Committee Members to introduce themselves, their relation to national/international associations, and also two recent highlights of work by their respective library associations. All the members gave very inspiring and interesting work of their library associations to increase their visibility and contribution to the United Nations Sustainable Development Goals. Among the recent works by their respective library associations that were highlighted include the following:

"Let America Read" Campaign amid book ban concerns by American Library Association and librarians in the United States; Asociacion de Bibliotecologos del Uruguay (ABU) would like the voice of Latin America to be better heard in IFLA's policies and program; the voice of African and MENA regions libraries and associations in IFLA; Building strong library associations and advocacy for library associations not being legislated with the government; sustainable development of libraries requires the building of strong associations.

4. Role and Work of MLAS

4.1 Role and Work of MLAS

The Chair highlighted that the mission of MLAS is to build and support strong, wellmanaged library associations. MLAS addresses the needs and promotes the interests of all types and sizes of library associations and brings together staff and elected leaders and representatives of these associations to support IFLA's Core Programmes.

MLAS has 20 Standing Committee Members and is the core of IFLA. MLAS Chair is an ex - officio of the IFLA Governing Board with voting rights. As of 10 January 2023, MLAS Section has 171 members comprising 163 National, International, and Regional Associations and 8 personal members.

4.2 MLAS Contributions to IFLA WLIC

MLAS present Open Sessions at the annual IFLA WLIC and partner with other IFLA groups to present and lead webinars and sessions. MLAS supports IFLA Core Programmes and Strategic Directions in their Action Plans.

MLAS hosted three Open Sessions at the Virtual IFLA World Library and Information Congress (WLIC) 2021 under the title "Advocacy: The Power of Networking." The sessions were held according to time zone with breakout rooms in all seven IFLA languages during the WLIC which was held from the 17th to the 19th of August 2021 virtually. The Working Group for these Open Sessions was Ute Engelkenmeier as the leader and MLAS Standing Committee Members.

IFLA MLAS and IFLA NPSIG hosted six webinars on "Empowering Library Leaders and Diversity Worldwide" in 2022. Over the course of six webinars, library associations from countries in each Regional Division presented opportunities they provide for new and senior librarians including leadership opportunities and how these library associations are fostering diversity within the library profession and leadership. The webinar format included interactive opportunities to engage attendees in conversations about those topics that will elicit best practices and recommendations and the needs of new and senior professionals. The insights gained from these webinars would then inform and enriched the MLAS Open Session at WLIC 2022 in Dublin, Ireland. The Working Group for these webinars comprised Loida as the leader and several MLAS Committee Members and NPSIG Convenor.

The IFLA MLAS Advocacy Impact Evaluation Project is a two-year project that started in November 2021. The final project result, the Review of Advocacy Impact Evaluation Practices in the Library Field, is scheduled to be published in August 2023. The project aims to strengthen the advocacy impact evaluation practice in the library field by providing a set of guidelines and recommendations about how to measure and evaluate the library advocacy impact. The project is led by Dijana Machala (Croatia) with participation from several MLAS Standing Committee Members.

5 MLAS Sponsors: Special Interest Groups (SIG)

MLAS is the sponsoring unit for the New Professionals Special Interest Group (NPSIG) and Women in Information and Libraries Special Interest Group (WILSIG). MLAS is part of the <u>Professional Division C</u>. Each SIG has a committee of up to nine (9) individuals and their term of office is two (2) years, renewable once. The members of the Special Interest Group Committee are appointed by the Sponsoring Section Standing Committees. Magdalena Gomułka from Poland is the NPSIG Convenor and Evviva Weinraub Lajoie from the United States is the WILSIG Convenor. Their terms will end in August 2023 after the IFLA General Assembly in Rotterdam.

Loida informed that the timeline for IFLA Officer Elections 2023 for the position of Chair, Secretary, and Information Coordinator are as follows:

- Officer self-nominations 01 June noon, 19 June
- HQ Officer verification.....10 July 12 July
- Announcement of 2023-25 Officers...... 13 July
- Officer run-offs, as needed...... 14 July 24 July
- Officer run-off election results announced...25 July

The IFLA Officer Election is a self-nomination process and will be managed by IFLA HQ. Only new and continuing committee members who have not reached Officer term limits may nominate to Officer positions. The Officer Roles can be accessed via this link: <u>2023-25 Officer Roles v.1[90422].pdf</u>

The closing date for self-nomination is 19 June 2023.

b) Description of Work by MLAS Officers

Loy Jyoon as the Secretary of MLAS for the term 2021-2023 gave an overview of her work which include the preparation and documentation of meetings. She stressed that one must be willing to learn new skills and devote time and energy. She thanked all the MLAS Colleagues for their support and mentorship. She also reported that she was the MLAS Deputised Representative for the IFLA Governing Board Extraordinary Meeting on 6 April and IFLA Governing Board Meeting on 17 April 2023 during the interim period of electing a new MLAS Chair. She reiterated that the MLAS Chair is an ex - officio of the IFLA Governing Board with Voting rights. The position and role of the MLAS Chair are very important as he represents the voice of the library associations and their members.

Loida as the MLAS Information Coordinator for two terms (2019-2021) (2021-2023) also highlighted her role and contributions in MLAS. Loida has been instrumental in organizing MLAS Webinars and external communications with other Sections and Units.
