- 1. Welcome (Anya)
 - a. Last time we met was in August.
- 2. Apologies for absence (Anya/Jeannie)
 - a. Follow up meeting on November 11th, 14 CET, for those who are unable to make it today due to any reason (time zone, travels, etc.).
 - b. Regrets sent by: Catharina, Alberta, Mazli (will attend the follow up, though)
- 3. Minutes from last meeting (Jeannie)
 - a. Business arising
 - i. Jeannie and Jeremiah will review and revise Terms of Reference for the PressReader Award WG.
 - ii. New lead for Midyear Meeting Working Group (WG)? Stephen will continue to fill in for this role.
- 4. IFLA PressReader Marketing Award: Jury Meeting report (Nick)
 - a. Elena: call for submissions is out on the website. Will distribute as widely as possible. There will be a WG meeting after today's BM.
 - b. The press release is being translated into many languages.
 - c. Translate press release into Russian? Russian is spoken in countries other than Russia and is one of the IFLA official languages. So, yes, it should be translated. Cindy suggested a Russian speaker from WLIC. **Action:** Nick will reach out to see if she can translate. Anya: if no luck, then will check via the Officers' BaseCamp to try to recruit.
 - d. Working on a request from Roxana to make graphics in Spanish/Portuguese to encourage more South American submissions

- b. Coaching Initiative (Anya): Started a review of the coaching in Dublin (coaches and coachees). Received some responses already. Online coaching starts on November 14th. To date, 5 sessions are booked. 8 coaches are available. Anya and Christie are coaches, representing M&M.
- c. Management Skill Building WG: Recent <u>IFLA CPDWL podcast on dysfunctional</u> and toxic <u>libraries</u> will be shared on its blog. One of the guests is a colleague of Jeannie's from the University of New Brunswick.
- d. Midyear Meeting (Stephen): The group has had 2 meetings since August. Haven't finalized the Midyear date yet. Made the decision to do programming based on a speaker, rather than interviews. Inviting the Dean at BYU to speak on managing innovation. Mazli came up with some example questions, but hope to give the speaker some flexibility, as well, regarding topics. Trying to avoid conflicts with date, but will aim for the usual time in February. WG is also working on a social gathering. Alberta put forward the idea of an event where members prepare a dish or show a picture of a food item and its meaning during our social. Usually, there are 3 days for the Midyear (social, presentation and business meeting). Action: Stephen will send out a Doodle poll regarding possible dates.
 - i. Stephen will be working with Megan Price re: logistics and marketing.
- e. Satellite meeting (Anya): The WG has not met yet. The Academic Committee went with a different theme on Open Access (Living in an Open World). We can do a Satellite on our own (or with the LGBTQ Users SIG). Need to get a commitment from Thomas (LGBTQ Users SIG). Roxana is a new member of the WG.
 - i. Feb 28th deadline to submit proposal
- f. 25th Anniversary of M&M (Jeannie). The group has met twice and is working on leveraging some documentation that has already been created by the Library History SIG Oral History Project. Nick and Cindy are reviewing the documentation and customizing so that it is relevant for interviews with significant M&M personalities over the years. Nick is the WG's liaison with the LibHist Oral History project and attended its last meeting in October. It is great to collaborate with the SIG, as we can follow established best practices and our work will complement their project. The WG is looking for volunteers; please get in touch if you would like to contribute. All documentation can be found via BaseCamp.

 Action: Jeannie will follow up with Anya as a potential interviewer and Jeremiah as a creator of a simple logo.
- 6. Community of colleagues (idea from Hans)
 - a. Hans. As a new member, still finding out how IFLA works. Would be good to have a community for members to come together, share information and ask questions about management topics, including sustainability, and IFLA structure. Stephen: have implemented **communities of practice** at his institution. Romeo: these structures are important for opportunities to exchange best practices. Josephine: can put on the Management Skill Blog to recruit like-minded colleagues. **Action:**

Josephine will follow up with Catharina and Hans to see if content can be created for the blog.
