- I. Report from Patrick Section D Chair
  - A new tool for the action plans will be rolled out and presented at the next WLIC in Rotterdam. It's called Infinity and is databased. IFLA staff is already working with it.
  - The switch towards an Open Access IFLA Journal is a slow progress, IFLA looks at business models and would like to stay with SAGE, but also looks into other publishers.
  - On 1st of May the new members of the sections will be announced
  - A lot of the WLIC program will be in hybrid mode. In principle all business meetings can be done hybrid. Also it is marked in the program, if the location is facilitating hybrid mode. If we have questions on this, we should ask Emmanuelle. The costs for the online participation will be out soon.
- II. Section Update- New Members and What to Expect We are expecting 9 new members (India, Mexico, South Africa, US, Fidj...). Our recruiting was very successful. According to Patrick, all of the new members are eligible for open officer's positions.

Anna suggests that we should also share the call with public libraries, since they also work in the field of citizen science. Sandy adds that our colleague Lilliana might have contact with citizen scientists, she will get in touch with her. Anna said she would contact someone from LIBER to share the call. We were also wondering if there will be simultaneous translation available. Also we should ask IFLA HQ how many recordings we can include in the program, because videos on the work of citizen science might be very interesting.
