INTRODUCTION TO THE ACTION PLAN

The 2023-2025 IFLAPARL Action Plan includes continuation of previous years' actions and addition of new actions that hope to meet challenges currently faced by parliamentary libraries such as AI's impacts and opportunities, innovative promotion of services products delivered, attraction of new patrons, reinforcement of our place in the democratic process and within parliamentary institutions, fighting against misinformation and fake news. We have kept our main objectives in mind while drafting this document that will lead the Section's initiatives for the next two years: to increase the effectiveness of parliamentary library and research services, to discuss and address emerging issues related to legislative processes; to promote openness, transparency, and the strengthening of democratic participation through the provision of information about legislation and parliaments to citizens; to promote the establishment of library and research services as a fundamental component in the development of democratic legislatures throughout the world; to exchange experience, knowledge and problem-solving strategies; to promote networking amongst parliamentary library and research services; and finally, to develop and promote standards and best practices in providing information and knowledge to parliaments

IFLAPARL 2023-2025 Action Plan is directly aligned with IFLA 2019-2024 Strategy. The four focus areas listed in IFLA 2019-2024 Strategy have been coded alphabetically A-D, to avoid confusion with the numbering given to IFLAPARL's outputs:

FOCUS AREA A - STRENGTHEN THE GLOBAL VOICE OF PARLIAMENTARY LIBRARY & RESEARCH SERVICES

Leveraging the work of IFLAPARL members and the existing global presence of IFLAPARL to demonstrate relevance to parliaments, development bodies and international organisations. Strengthen the relevant work and profile of IFLAPARL and its members. All with the goal of increasing the effectiveness of parliaments through knowledge – a goal that also supports UN Sustainable Development Goal 16.

FOCUS AREA B – INSPIRE AND ENHANCE PROFESSIONAL PRACTICE IN PARLIAMENTARY LIBRARY & RESEARCH SERVICES

> Continuing IFLAPARL's long-standing work in developing professional guidance and provision of training.

FOCUS AREA C - CONNECT AND EMPOWER PARLIAMENTARY LIBRARY & RESEARCH SERVICES AND THEIR STAFF

Maintaining the regular programme of a annual meeting for the section. In 2024 an alternative to WLIC Pre-Conference must be found. Support regional associations of parliamentary library & research services and strengthen connections with and between them.
